5. EXECUTIVE COMMITTEE/DIRECTOR COMMENTS

Supervisor Benoit introduced Supervisor Tavaglione and welcomed him to the Executive Committee meeting. Supervisor Benoit also announced that there would be a Board of Supervisors meeting held in Palm Desert at the CVWD Board Room on October 1st.

Supervisor Benoit and Tom Kirk recognized former Desert Hot Springs City Manager, Rick Daniels, for all of his work in the Coachella Valley over the years. Mr. Daniels was wished well.

Mr. Kirk announced that the major amendment, that adds the City of Desert Hot Springs into the CVMSHCP, has been posted in the Federal Register. CVAG anticipates the public hearing finalizing the major amendment by the end of the year or the first part of 2014. Mr. Kirk reported that by the City joining the plan, all of the permittees will experience an 8% reduction in fees.

Mr. Kirk concluded his comments by inviting the Executive Committee members to the Energy Summit on October 3rd and 4th to be held at the Palm Springs Convention Center.

- F. APPROVE AMENDMENT 1 BETWEEN CVAG AND JEWISH FAMILY SERVICES (DBA DESERT SOS) FOR OPERATIONS OF ROY'S DRC, FOR CONTRACT PERIOD STARTING NOVEMBER 1, 2013 THROUGH OCTOBER 31, 2014; AND AUTHORIZE EXECUTIVE COMMITTEE CHAIR TO EXECUTE AGREEMENT AT A BED RATE OF \$36.15 FOR 90 BEDS

7. DISCUSSION / ACTION

A. Second Reading and Adoption of Proposed Ordinance No. 13-001, an Ordinance levying a special tax for fiscal year 2013-2014 and following fiscal years solely within and relating to the Coachella Valley Association of Governments Community Facilities District no. 2013-1 (Clean Energy) – Katie Barrows

IT WAS MOVED BY MAYOR PARKS AND SECONDED BY MAYOR HARNIK TO WAIVE FURTHER READING AND ADOPT ORDINANCE NO. 13-001, “AN ORDINANCE LEVYING A SPECIAL TAX FOR FISCAL YEAR 2013-2014 AND FOLLOWING FISCAL YEARS SOLELY WITHIN AND RELATING TO THE COACHELLA VALLEY ASSOCIATION OF GOVERNMENTS COMMUNITY FACILITIES DISTRICT NO. 2013-1 (CLEAN ENERGY).” THE MOTION CARRIED WITH SUPERVISOR STONE VOTING NAY.

B. Contract with Southern California Edison for Energy Efficiency Strategic Plan funding for City of Palm Desert – Katie Barrows

IT WAS MOVED BY SUPERVISOR BENOIT AND SECONDED BY MAYOR ROCHE TO APPROVE A CONTRACT WITH SOUTHERN CALIFORNIA EDISON FOR \$160,200 FOR CVAG TO PROVIDE ENERGY EFFICIENCY STRATEGIC PLAN PROGRAM (GREEN FOR LIFE) ELEMENTS TO THE CITY OF PALM DESERT. PENDING FINAL REVIEW OF CONTRACT AND STATEMENT OF WORK BY CVAG GENERAL COUNSEL AND EXECUTIVE DIRECTOR, AUTHORIZE THE EXECUTIVE DIRECTOR AND/OR CHAIR TO SIGN THE CONTRACT AND TAKE ACTIONS NECESSARY TO IMPLEMENT THE PROGRAM, INCLUDING PROCURING CONTRACT SERVICES TO ASSIST CVAG AND PALM DESERT. THE MOTION CARRIED.

C. Consider Memorandum of Understanding between the Riverside County Transportation Commission (RCTC) and the Coachella Valley Association of Governments whereby RCTC agrees to establish the Coachella Valley Rail Fund and to set aside and maintain Ten Percent (10%) of Transit Development Act (TDA) funds in

to that Fund, and agrees to distribute those TDA funds upon the administrative direction of the CVAG Executive Committee – Allyn Waggle

IT WAS MOVED BY SUPERVISOR ASHLEY AND SECONDED BY SUPERVISOR STONE TO APPROVE THE PROPOSED MEMORANDUM OF UNDERSTANDING BETWEEN THE RIVERSIDE COUNTY TRANSPORTATION COMMISSION (RCTC) AND THE COACHELLA VALLEY ASSOCIATION OF GOVERNMENTS WHEREBY RCTC AGREES TO ESTABLISH THE COACHELLA VALLEY RAIL FUND AND TO SET ASIDE AND MAINTAIN TEN PERCENT (10%) OF TRANSIT DEVELOPMENT ACT (TDA) FUNDS OTHERWISE AUTHORIZED TO BE RELEASED FOR USE IN THE COACHELLA VALLEY, AND AGREES TO DISTRIBUTE THOSE COACHELLA VALLEY SPECIFIC TDA FUNDS UPON THE ADMINISTRATIVE DIRECTION OF THE CVAG EXECUTIVE COMMITTEE AND IN COMPLIANCE WITH TDA LAW. THE MOTION CARRIED.

D. Consider Amendment Number One to the Agreement with the County of Riverside for the Widening of Fred Waring Drive between Adams Street and Port Maria Road – Allyn Waggle

IT WAS MOVED BY SUPERVISOR BENOIT AND SECONDED BY SUPERVISOR STONE TO APPROVE AMENDMENT NUMBER ONE TO THE AGREEMENT WITH THE COUNTY OF RIVERSIDE FOR THE WIDENING OF FRED WARING DRIVE BETWEEN ADAMS STREET AND PORT MARIA ROAD IN THE AMOUNT OF \$4,845,000. THE MOTION CARRIED.
